FINAL REPORT NEIGHBORHOOD BUSINESS DISTRICT SUPPORT GRANTS

Neighborhood Business District Support Grant Funds were used to establish two new grant programs to support Cincinnati's Neighborhood Business Districts in an effort to alleviate the impact of the COVID-19 pandemic. The **Small Business Support Program** offered neighborhood-serving small business the opportunity to reinvest in their operations, storefronts and employees. The **Infrastructure Grant Program** gave neighborhood-serving nonprofit

organizations the opportunity invest in public space and amenities to better support safe community gathering and to reinvigorate certain places in Neighborhood Business Districts that had been negatively impacted by Covid-19 mitigation measures.

In total, HomeBase deployed **over \$2.5M in grant funds to 41 small businesses and 14 nonprofits** throughout the Cincinnati during the grant term. Grants made with NBDSG funds in both the Small Business Support and Infrastructure Grant Programs demonstrated critical investment in the city's neighborhoods and small businesses.

NEIGHBORHOOD BUSINESS DISTRICT SUPPORT GRANTS SMALL BUSINESS SUPPORT PROGRAM

The Small Business Support Program was created in response to the adverse economic impacts of the COVID-19 pandemic to aid small businesses in continuing to operate and thrive as a vital part of our city's neighborhoods. Funds offered direct support for operations and the opportunity to improve the built environment, especially to enhance outdoor spaces providing for COVID-19 mitigation.

The negative economic impacts of the COVID-19 pandemic were mitigated for small business grant recipients in funds provided for operational expense support, including providing for payroll expense, purchasing fixtures and equipment and the repair or improvement of real property, especially to mitigate the spread of viral illness and increase visibility while operations and revenue were challenged by the ongoing impact of the pandemic.


A total of \$410,000 in grant funds were disbursed to small businesses throughout Cincinnati. During the grant term, a total of **41 Small Businesses** were supported by Neighborhood Business District Support Grants deployed through the Small Business Support Program.

The small Bbusiness recipients hold 14 business enterprise certifications:

- 4 Minority Business Enterprises
- 7 Women Business Enterprises
- 3 Small Business Enterprises



Funds were often used for fixtures and equipment allowing businesses to increase production or improve efficiency, conduct property repair or improvement and cover payroll and other staffing expenses over a discrete period during the grant term.

Small business grant recipients also commonly used funds for operational expenses, for 10% of recipients, to cover rent expenses, also for 10% of recipients, and to produce marketing and advertising materials, for 8% of recipients, during a time when reduced revenue and increased operating costs challenged the ability of many businesses to continue to operate.

However, investment in fixtures and equipment or property improvements were the most common use of funds, occurring for 20% and 16% of small business grant recipients, respectively, faced with the challenge of responding to pandemic restrictions to operations and changes in demand for services resulting from such restrictions. For example, Sweets & Meats, in Mt Washington, used funds to purchase and build of a smoker affixed to a trailer for use managing changing demand for menu items in a way that allowed them to continue operating from their storefront.

The Infrastructure Grants Program was created in response to the community impact of the COVID-19 pandemic, to facilitate change in neighborhood infrastructure in order to foster safe community gathering opportunities and provide support to the ongoing work of building community, especially with newly necessary public health considerations.


Funds offered through the Infrastructure Grants provided the opportunity to improve the built environment, especially to enhance outdoor spaces providing for COVID-19 mitigation, with priority given to enhancing the built environment in the City's recognized Neighborhood Business Districts.

A total of **\$2,219,240** in funds were awarded to neighborhood serving nonprofit organizations in Cincinnati.

Grant funds leveraged an additional \$7,452,611 across all funded projects (3.3:1). Leveraged funds were largely concentrated among a few development projects undertaken by College Hill Urban Redevelopment Corporation (Hollywood Apartments, Dow's Corner, the Knight Building), The Community Builders (storefronts at Avondale Town Center), Walnut Hills Redevelopment Foundation (Business Improvements) and Northsiders Engaged in Sustainable Transformation (4024 Hamilton, Knowlton's Corner gateway).

16 projects were supported by Neighborhood Business District Support Grants through the Infrastructure Grants Program during the grant term; several of which facilitated investment in storefronts and retail spaces in the neighborhood served by the recipient organization.




Infrastructure Grants Awarded by Neighborhood



One of the primary uses of grants made under the Infrastructure Grants Program was the development or improvement of outdoor dining spaces, in 25% of projects, followed closely by using funds for small business infrastructure or facade improvements, each in 19% of projects.

In some instances, the recipient utilized funds to improve covid-safe spaces at properties under development by the grant recipient. Camp Washington the Clifton Business CURC, & Professional Association, the Mt Adams Business Guild, Northsiders Engaged in Transformation, Sustainable the Over-the-Rhine Chamber of Commerce, The Community Builders, Community Happens Here, the Community Council, Evanston Madisonville CURC, the Roselawn Business Alliance and Walnut Hills Redevelopment Foundation all supported neighborhood small businesses with infrastructure, facade, and outdoor dining improvements.

Many recipients of the Infrastructure Grants utilized funds to support investment in small businesses to improve, enhance or build new outdoor dining spaces in an effort to support further revenue opportunities to keep neighborhood-serving small businesses operating while maintaining safe operational practices in the wake of change resulting from the pandemic.







NEIGHBORHOOD BUSINESS DISTRICT SUPPORT GRANTS PROMOTING EQUITABLE OUTCOMES

Evaluation criteria for applications made to the Small Business Support Grants and Neighborhood Business District Infrastructure Grants programs included assessments of project location, to ensure the provided support would benefit low and moderate income communities, and assessments of the overall community benefit through support for creating or retaining affordable housing and creating or retaining significant jobs or payroll.

In addition, evaluation criteria included assessments of the project scope and budget, organization or business capacity, leveraged funds and sources, project implementation, the impact on the Neighborhood Business District and the demonstrated mitigation potential for impacts of the COVID-19 pandemic.
